In pursuance of the Hon'ble Gauhati High Court, Guwahati Notification bearing no. 18 dated 24-03-2020, the working under the establishment of the undersigned shall remain restricted with effect from 25-03-2020 till 04-04-2020.

In suppression of all previous Order(s), the roster arrangement of the Judicial Officers and employees of this establishment as well as the Judicial Officers and employees of the establishment of the Chief Judicial Magistrate, Barpeta is restricted with matters of urgency involving liberty and remand matters related to fresh arrests and extension of remand.

It is provided that one Judicial Officer each (as per the direction of the undersigned or the the Chief Judicial Magistrate, Barpeta) from the establishment of the undersigned and the Chief Judicial Magistrate, Barpeta shall work on working days for carrying out the directions of the Hon'ble Gauhati High Court, Guwahati.

Moreover, all the concerned are also directed to take note of the following points:

- a. The District Courts shall deal with matters of extreme urgency involving liberty, only and remand matters related to fresh arrests and extension of remands, only,
- b. Matters which are already fixed for listing and hearing in the District Courts upto 04-04-2020, shall stand deferred, unless extreme urgency is shown for immediate hearing of the matter.
- c. All the Judicial Officers are directed to remain present and not to leave their respective stations except in extreme urgency with due permission.
- d. All those ministerial staff who are not required to report for duty on any given day, shall not leave the station headquarter under any circumstance without prior permission. They will have to make themselves available for duty on call and they shall be deemed to be on duty during the entire period.
- e. In case of any urgency, the District and Sessions Judges / Presiding Officers may call upon such off-duty staff to report back for duty immediately.

This Order will come into force with immediate effect.
