This is for the information of all concerned that, Hon'ble Gauhati High Court vide Letter No. HC.VII-44/2018/11457/A dated 28-11-2022 has forwarded a copy of the standard operating Procedure issued by the Judicial Department, Government of Assam, dated 21.10.2022, wherein it is mentioned that the Government of Assam has decided to go for withdrawal of cases by invoking Section 321 Cr.P.C, 1973, where punishment is upto 3 (three) years or fine or both under the Indian penal code or any other Special Act/ Regulations, registered up to 14-08-2022.

Pursuant to the aforesaid decision, Barpeta District Judiciary has prepared court-wise detailed list of petty/minor criminal cases, punishable upto 3(three) years or fine or both, which are likely to be withdrawn accordingly, all parties concerned are hereby requested to check the details of their cases in the Barpeta District Judiciary's website (<https://www.barpetajudiciary.gov.in/>) or in the Notice Boards of the establishment of District & Sessions Judge, Barpeta, and Chief Judicial Magistrate, Barpeta.

Further, if any victim is aggrieved with the proposed withdrawal, he/she will be at liberty to file complaint case on their own, to proceed with their grievance and in appropriate cases such eligible victim may approach for legal aid before the District Legal Services Authority, Barpeta.

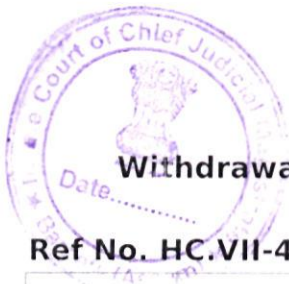
