1. The candidate should have minimum educational qualification of Class VIII standard and those who have passed HSSLC or above shall be ineligible to apply for the said posts. Candidates possessing special skill may be given preference on need basis.
2. The candidate should not be more than 40 years of age and less than 18 years of age as on 01-01-2023. The upper age limit is relaxable as per govt. norms.
3. Candidates may drop their application in a sealed envelope with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card along with 3 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side, in the "Drop Box" of the Office of the District & Sessions Judge, Barpeta or may send the application form along with all documents by post to the office address mentioned below.
4. Candidates serving in Govt. Department should submit their application through proper channel.
5. Applicant must indicate prominently the name of the post applied for on the right hand corner of the envelope containing the application.

6. Candidates must have registered their name in the Employment Exchange and the Registration is to be valid as on date of submission of application.
